# IRTL's RU-486 Press Release Reaches Beyond Iowa

The call came into the lowa Right to Life office from a young woman in another state.

She called us because a friend had given her lowa Right to Life's release about

the dangers of Planned Parenthood of Greater lowa's walk-in RU-486/ Medica-

Planned Parenthood told her they would not do the medication abortion before she was 8 weeks along — against FDA recommendations.

tion Abortions. She was calling to get more information because she was pregnant and her doctor advised her to go to Planned Parenthood to get this abortion.

At Planned Parenthood, she was told they would not do the abortion before she was eight weeks along. But the woman knew from our press release, that the Food and Drug Administration (FDA) says that RU-486 abortions should not be performed after 49 days (6 weeks and 1 day) into a woman's pregnancy.

We are not sure why Planned Parenthood would say she could not have the abortion before she was eight weeks along — it might have to do with when they could fit her into their

schedule, which is a frightening thought.

The woman asked Planned Parenthood if she could bring her doctor with her to her appointment. Planned Parenthood said, "No."

She told us she was scared, because she had a friend in the hospital that had just gone to Planned Par-

enthood for a surgical abortion.

We talked to her about adoption. She liked the idea, because it seemed like the right thing to do, since she and her husband were both adopted.

She called back to let us know that she talked with her husband and they agreed to choose life for the baby and let him be adopted.

Your work in helping us get out the word on the dangers of Planned Parenthood and RU-486 **is** making a difference and saving lives.

## 40 Days Wrap-up: 614 Babies Saved

40 Days for Life is growing in Iowa — the prayer vigil outside abortion clinics ran from September 24-November 1 and included participants in Des Moines, Bettendorf, Council Bluffs and Sioux City.

Amazing things happened on a national level during this fall's 40 Days for Life effort:

## **Stop FOCA Flyers Available**

DES MOINES—lowa Right to Life now has "NO FOCA" flyers available on its website.

The Freedom of Choice Act (FOCA) is a congressional bill introduced last year that would eliminate over 550 pro-life laws. It would permit tax funding of abortion and legalize abortion on demand for any reason through the 9th month of pregnancy in all 50 states.

President-elect Barack Obama promised Planned Parenthood at

their 2007 Action Fund conference that the first thing he would do as president would be to sign FOCA.

IRTL is rallying pro-lifers to contact their Senators and U.S. Representatives and urge them to vote against FOCA.

- There were at least **614 turn- arounds** across the U.S., where
  women seeking abortion changed
  their minds. There were at least
  three babies saved here from Planned
  Parenthood in Des Moines.
- Several people have **quit their jobs** in the abortion industry and clinics have advertised immediate openings on their staffs.
- A number of **abortion centers have been closed** on days when abortions are usually performed.
- Tens of thousands of people have taken part in 40 Days for Life, many

engaging in pro-life activities for the first time in their lives.

### Making a Killing

DES MOINES—Spring is construction season, so keep an eye out in your churches and school districts for construction projects bid on by Weitz Construction. Des Moines-based Weitz Construction is the builder of the largest Plannned Parenthood abortion processing center in the country in Denver, Colorado. Weitz is currently working on Western Hills Elementary in West Des Moines and was the contractor for Valley High School's recent renovation. Fred and Emily Weitz sit on Planned Parenthood of Greater Iowa's Board of Sponsors and are also major donors

to lowa's #1 abortion business.

A company that profits from the killing of innocent children should not be paid our tax dollars to build our schools, our churches and other facilities that house our children.

### **Ultrasound Law—OK**

OKLAHOMA CITY—Oklahoma's new ultrasound law went into effect on November 1, 2008. The law provides women considering abortion with ultrasound images of their child and an explanation of the ultrasound.

14 states now have ultrasound laws

where a woman is show the ultrasound images or offered a chance to see them.

## Planned Parenthood Stops Selling Baby Shirts

### RU-486: Don't Believe Planned Parenthood

### **Planned Parenthood Ignores FDA to Increase Profits**

DES MOINES—Planned Parenthood of Greater Iowa is promoting walk-in, no appointment abortions at its locations across Iowa with dangerous RU-486 abortions (also known as "medication" or "chemical" abortions). And there's NO DOCTOR in the room. Instead, PPGI's doctor consults by webcam from another city.

The FDA recommends women have an RU-486/medication abortion in a doctor's office. Planned Parenthood sends women home to have the abortion, because it is **MORE PROFITABLE FOR PLANNED PARENTHOOD**:

- Less staffing for Planned Parenthood, means less overhead cost.
- More exam rooms available, so Planned Parenthood can do even more abortions and increase their profits.
- Less traumatizing for Planned Parenthood's staff. Staff turnover is reduced, when no one has to deal with the woman's pain, clean up the blood and count the baby parts to make sure the abortion was complete.
- Clinic staff doesn't have to deal with the disposal of the baby's body. The woman can just flush it down the toilet at home or throw it into her own garbage.
- Planned Parenthood saves money by not having a doctor in the room. Women who go to Planned Parenthood pay the price, because there are so many things that can go wrong that cannot be diagnosed by a webcam doctor.

If you go to Planned Parenthood and what they are telling you doesn't seem right, or something is making you uncomfortable, **TRUST YOUR INSTINCTS AND LEAVE**.

### **RU-486 KILLS**

Women who have died as a result of RU-486 / medication abortions, died from:

Clostridium sordelli – bacterial infection, like toxic shock

Bleeding to death

Ruptured ectopic pregnancy

Massive heart attack

IMPORTANT: One of the biggest dangers with medication abortions is that major complications—Excessive Bleeding, Cramping, Nausea, Vomiting, High Fever—can be mistaken for typical abortion complications.

### How RU-486 Works

RU-486, also called a "medication" or "chemical" abortion. The woman is first given RU-486 pills, also known as mifepristone or "Mifeprex," and then a few days later, instructed to take a second drug, misoprostol, which causes the infant to be aborted.

## If you, or someone you know has complications from an RU-486 abortion:

- Go IMMEDIATELY to your nearest hospital Emergency Room.
- Do not deal with abortion clinic personnel who say, "Just take more pain medicine." That has cost too many women their lives. Get to an Emergency Room.
- Tell the Emergency Room health professionals that you have had an RU-486 abortion – to save your life, they need to know what is going on.
- Don't worry about health insurance your life is more important. Stay alive and work out the details later.

**Planned Parenthood's Dirty Little Secret:** If you are injured by the abortion, Planned Parenthood will BLAME YOU. In a recent court case in Nebraska, a Planned Parenthood abortionist punctured the uterus of a woman, who nearly bled to death. Planned Parenthood's attorney said, "She knew the risks." The abortionist, Dr. Meryl Severson, also practices in Iowa.

### The Morning After Pill Vs

#### **Medication Abortions**

The Morning After Pill or "Plan B" is **NOT** a medication abortion. Rather it is a pill with a high dosage of the hormone found in birth control pills. It prevents an embryo from implanting in the womb.

On the other hand, RU-486, which is a medication abortion, is given to a woman who's unborn is already growing in the womb, even up to 7 weeks along.
